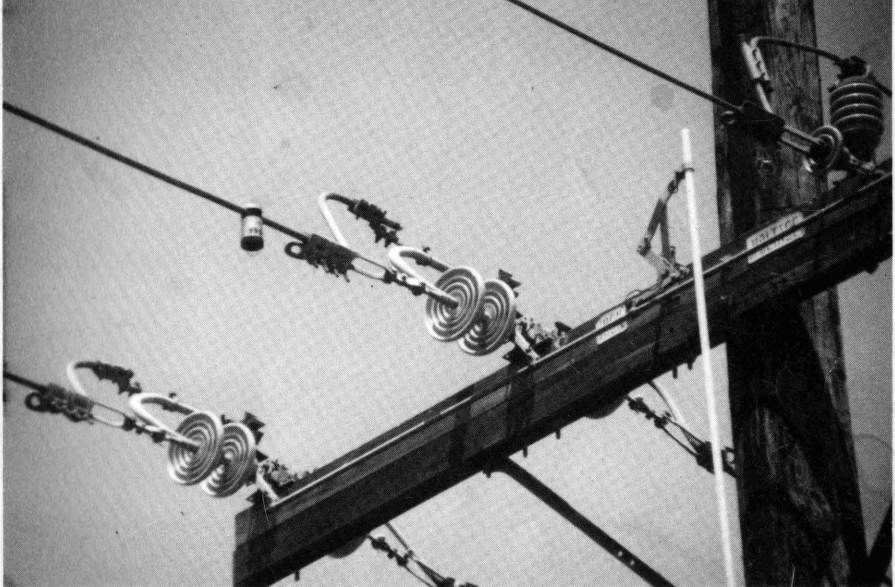

Concerning the Hallmark Card redbox... it's really simple. First, you grab one of the Hallmark cards that you can record your voice on... It's really a digital recorder in a card, so ANY digital recorder will work. Anyhow, once you have the card (or recorder) you need to find the redbox tones. Look for a file on your local hacker bbs called "QUARTER.WAV" When you get the .WAV file, play the sucker on your computer and you'll hear through your sound card/speaker setup the "quarter" sound produced by a red box. Record this sound into your digital recorder/card.... play it back like a RS red box or any other red box. It works. Back in the 80's, people used tape recorders to do this very thing.... and IT worked, too. Thanks for the info on Page-Mart, btw...

Dear Zack,

This "phone card" I have sent is a satellite communications access card. We used them on our ship (U.S. Navy) for emergency calls to home, etc... it cost \$35.00 for five minutes! Dear Blacklisted,

I love your magazine. Blacklisted! 411 is a great asset to the hacking community I have 3 questions to ask you guys.

- 1) Do you have any BBS #'s in the 619 area code? (SoCal)
- 2) Do you have any colored box plans?
- 3) Do you know how to modify a radio or scanner to pick up the higher kHz frequencies? (1700+)

If so, can you please, please, PLEASE print them or send them to me very soon. Here are the plans to design a Bud Box. Can you print them for everyone to use?

The Bud Box is a phone that lets you tap into your neighbor's phone line to eavesdrop, make free calls on their line, or just whatever. Here's how you do it:

What you need:

phone cord- 99 cent store (the kind that goes from wall to phone)

phone- just any old phone (one piece is easier to carry)

alligator clips - radio shack (real cheap)

some loser's house

What you do:

First take the phone cord. Remove the plastic end. You then need to remove the outer plastic (about 3" back). You now should have four wires next to each other. Cut the 2 outer

wires off. Now you should have 2 wires (the ones that were in the middle) These will usually be red and green. Strip the colored coating off of each one (just remember which is which). Inside, there should be a bunch of tiny copper wires. Attach these wires to one alligator clip each (I get the clips with the screw-on connectors). Now, plug the uncut end into the phone, and you're done. Pretty easy, huh? To tap into your neighbor's phone line you need to find their little box with the bell logo on it (about 3"x3"). You can usually find it close to the ground by their electric meter. Take off the cover 2nd you should see five screws. Attach the red clip to the screw with the red wire, and the green clip to the screw with the green wire (respectively). If you hear a dial tone, success! If not try switching the alligator clips around. There you go! I hope you were able to understand my directions.

Glenn, just how bad is your credit? If it's not "bad" you should be able to lease all the computers you ever wanted... The companies that lease computers are pretty relaxed around here, we've noticed.. In fact, we've known people with BK's who still get approved for leasing computers, cars, boats, you name it. If you have unpaid debts that are in collection right now, we suggest a couple of different tactics..

One: contact the collection agencies or creditors and tell them you want to settle the debt but at, say 50% of the owing

balance.. explain that you are REALLY down on your luck and you are considering bankruptcy.... Any creditor of an unsecured loan (ie: credit cards) will pretty much shit their pants trying to collect ANY amount they can from you. Now, once you tell them you want to settle, also tell them you will settle on one condition: they remove ANY negative remarks from your credit reports. Get it in writing. it works. You can get this type of settlement done for as little as 30%, if you know how to deal with the creditors (for unsecured loans only) ... mortgages and car loans don't work like this... you'll lose the house or the car.

Two: (ahem!) hire a lawyer (we hate to suggest this one) that deals specifically in this sort of thing... do NOT go for those "we fix your credit" BS. they're just playing you for a fool.. they know you're desperate and will take advantage of you with tactics that just plain don't work.

Any other methods may just fall into downright illegal activities which we would recommend staying away from...

If you want a computer really bad, why not get a good friend to co-sign on the lease... In fact, don't lease.. that's such a waste of money.. get a small personal loan (with a cosigner) and BUY a computer.. a GOOD one.

With regard to Starry Night's query of objects on a utility pole (3Q97) the objects he has circled are blade switches. They allow the power in the lines to be turned off for installation and maintenance. The utility tech puts on a seven stick (so called because the hooked end looks like 7) into the ring on the switch and pulls it open. They also contain a fuse which way be what he saw being repaired. The rectangular objects are capacitors to adjust the power factor (the ratio of voltage phase to current phase). They are necessary because most electrical loads are inductive - motors and fluorescent ballast. Everything else in the picture is ceramic insulator to prevent shorts through the wooden supports. If Starry Night climbs up there, he'll just blow the fuses when he electrocutes himself.

RE: Photo on page #8 V4, I3. The three circled objects in the picture are fused switches which protect what appears to be transformers (in the same photo). The electric wires in the picture carry VERY HIGH VOLTAGE! Do not attempt to go anywhere near them or you will certainly FRY. Linemen use long fiberglass poles (non conductive) to operate these switches. Furthermore, operating these switches may cause wires to become energized that should not be energized and may present danger to someone else. Hack Safely!

Dear Blacklisted:

Hey I just picked up your mag for the first time and truly appreciate your efforts. I just want to drop a quick note in response to a letter sent from "Starry Night" in your October 97 issue. It's hard to tell exactly from his comments what he's referring to, but I can describe most of the objects in the pic: The circled items that he calls paddles are actually "cut-outs" and are basically high-voltage bayonet switches that will open up or close a high voltage circuit. The "coil" object is a lighting arrester, believe it or not. The top side of the arrester is connected to the high voltage circuit, and the bottom side is grounded. When there is a lightning surge, the current jumps the gap inside the arrester and goes to ground (thereby being redirected away from the circuit). The big boxes in the metal

frames are large capacitors and are for limiting "reactance" on the power line (it improves the efficiency of the line, so more of the stuff is available for doing work). Since the cutouts are in the "open" position, it is likely that the power guys were worried that either a lightning arrester failed or there is some malfunction with one of the capacitors. "Closing" the cutout might short out the line and drop power to the neighborhood if this is true. Finally, no matter how much I hate the monopoly of the power company, I strongly advise Starry Night NOT to climb up the pole or touch anything that might be hanging down. The lines are likely to be about 12kV and are enough to vaporize any human body on contact. If there's a valid concern about crap hanging down, call the power dudes up and tell them to fix their shit, or threaten to report them to the P.U.C. if nothing happens. Best Wishes,

Dear411,

In all of my years being involved with the underground scene I have constantly been aware of the vast support of freedom of speech and first amendment acknowledged rights; observing our individual rights to decide our own spiritual beliefs, to be able to express ourselves verbally or literally as we see fit, and to have a governing body that is not tied or

directly linked to any ecclesiastical organization or religious institution.

As many have seen over the years of our short lives, these promises of constitutional autonomy are mere holograms of liberty, as political dictators and religiously fueled special interest groups headed by fascists like Tipper Gore, have more or less decided for us what we should or shouldn't be permitted to access to. Whether this has been access to things like "booty rap," the allegedly suicide inspiring Judas Priest and Ozzy Osborne albums, "gangsta" rap, "dangerous books such as Paladin Press's "Hitman," or any of the other myriad's of underground publications that have had tabs kept on them by federal agencies, it has still been acknowledged by those in the punk rock community that this type of prohibition is wrong. Not necessarily because we believe in singing about how many girls we "fuck" or how many "suckas we capped cut us they was steppin' to us," but because we recognize that if someone wants to express themselves that way, then they should, as autonomous human beings, be permitted to do so with no interference or legislation from the governing bodies.

To this degree I must applaud the underground scene all and give everyone the proverbial "pat on the back." Believe it or not we have been quite successful at keeping their idea banning at bay (while not yet actually being able to stop them altogether). However, infringement on personal autonomy does not end with prohibiting or limiting what we can say. It also is encompassed by limiting or prohibiting what we may own or what we may do. Now obviously this does not include just running around town raping and killing people, because by the very nature of these actions you are stripping the freedoms and liberties away from those whom you are committing actions against. No, what I am speaking of is far more sinister, and has, for reasons unknown, not been opposed to any extent by members of the punk rock community. This bit of insidious legislation is commonly referred to as "Gun Control," ironically enough is supported and condoned by the vast majority of so called "anti-authoritarians."

The reason for this evades me. If banning or legislating the ownership of firearms actually could make this a more just and peaceful world then perhaps I could see the logic behind it. However, gun control legislation such as the Nation Firearms Act, the Gun Control Act of 1968 and the so called "Crime Bill" (or "Brady" Bill) of 1994 have no impact whatsoever on federal or local "law" enforcement agencies. Perhaps you are unaware of this but since the 1930's we lowly civilians have been barred of the right to own a small piece of metal with a spring that would enable our semiautomatic rifles to fire fully automatically, while at the same time there are now more than 400 local police forces who are equips with military surplus full auto M-16's. We are not talking about S.W.A.T. teams and all of their fancy toys. These are the beat cops rolling around in their cruisers with assault rifles in their trunks. At this time there are more than 1,000 other police forces trying to get approval for similar firearms (which they probably will get within the next year).

Perhaps gun control doesn't frighten you. Perhaps you ignorantly view gun owners as backwoods dipshits out looking for "grub," (which some undoubtedly are). However, in regards to all gun owners, you couldn't be further from the truth. I'm not going to give you a history lesson but you must realize that the first thing every modern dictatorship has done before instituting their reign of terror was gradually and completely restrict the civilian populace from owning and possessing firearms, (i.e. Adolf Hitler and Nazi Germany). Why? Because weapons are multipliers of strength. The corporate government has nothing to fear of several thousand

unarmed revolutionaries who could be easily squashed by the state and their superior armament. However knowing that the masses possess these multipliers of strength and will not give in when the government tells them that they can no longer be trusted with the responsibility of owning a piece of metal with a trigger, a hammer, a bunch of springs and pins in it, could definitely keep autonomy in the hands of the masses for a little bit longer.

If the state did decide to instill 100% totalitarian dictatorship (which they are well on their way) then how would they go about doing so? How could they possibly bully a well organized mass of people who simply want to live free autonomous live, who were armed to the teeth? The answer is they couldn't. Police are slaves to the corporate interest but they don't want to die just to take guns away from people who aren't bothering anyone in the first place.

Take, for example, a situation that I and two close friends of mine were confronted with a month or two ago. We were moving back from the west coast to Ohio when our van, (filled with all of our firearms), overheated in the middle of the night on an Indiana interstate. We decided to let it cool down and take a look at the engine in a minute. Not long after, we saw lights flashing behind us. Sure enough, it's officer John Lawman, coming to see what is going on. Quickly we unloaded the guns that we were carrying and removed them from our holsters. The driver of our van went to tell the officer that there was no problem, we just needed to let me sonofabitch cool down and we would be on our way. Well, this wasn't quite acceptable to Officer Lawman. He decided that he needed to check our identification and the driver needed to be patted down and wait in the cruiser. Upon the officers "Terry Frisk" he discovered a full handgun magazine and a concealed carry holster still attached to my friend's belt. Time to call for back up...

Six cops were there now. My girlfriend was flipping out in side the van. I told her to be cool and everything would work out. As far as the cops knew, all of our guns were being carried legally. We had several rifles, a shotgun and a few thousand rounds of ammunition in the van, in addition to several handguns.

Well, long story short, we knew the cops had probable cause to search the van so we consented to a search to get all of this bullshit over with (not that I am recommending this, you should normally never consent to any search). The officers couldn't believe all of the weapons that we had. Aside from that, they were astonished by the other survival gear that we had, bullet proof vests, gasmasks, night vision, several, dozen loaded magazines.

"Why do you have all of this? Are you in some sorta militia?" They asked.

"No, we have this because this is what we are into. Because we want to and because we can," we replied. We continued to "chat" with the obviously nervous and intimidated officers.. We never spoke down to them and we never "got smart" with them. We just spoke as if this were a routine aspect of travel, like paying a toll and we would soon be on our way. Well, they ran a check on all of the guns... "1080" the dispatch said, they all came up legal. So the cops let us go, but it was obvious that they were intimidated.

Why were they intimidated? Because we had power over them. We had the capacity to end their lives if they decided to oppress us. Because if they decided to shoot us we had the capacity to protect our bodies from their bullets. Because they once again were given the role as our servants rather than us assuming the role as their subjects who they "keep in line."

I am not even beginning to suggest that owning firearms will solve all of the world's problems but it is obvious that the governments of the world do not want their subjects to have possession of things that will make the government subject to their approval. They want the guns, they want the magazine capacity, they want the select fire capability, they want the power. And if we continue, as I did for so many years, to

believe that supporting their totalitarian organizations goals, like those of "Sarah Brady's Handgun Control" The United Nation's (who have publicly stated that it is their goal to disarm the civilian populous of the world by the year 2000), me Parliament of the U.K., Canada and Australia (who have in recent years invoked an outright ban on civilian ownership of firearms while simultaneously beefing up the armament of me "authorities," then we shall be to blame on the next "Krystal Nacht."

Please think about what I have said and feel free to write or argue with me if you disagree, or correspond if you agree. We have a lot of work to do if we are to ever achieve a free and just world and now is the time to start. I do hope that you realize that this has not been a letter about guns, it has been a letter about autonomy and what will work best to insure our freedom and limit the power of the corporate governing bodies in the future. Now for the redbox tones. The 1000Hz tone listed below is NOT a DTMF, it's a single tone. (Strange, huh?) Anyhow, supposedly, for this to work, you need an operator to connect your call. We're not sure of the effectiveness of this, but here's the info to chomp on. If anyone out there has any specific information regarding this, please forward it to us. Anyhow, here's your redbox tone:

10p Length 200 milliseconds. Freq: 1000Hz.
20p Two times the Above.
50p Length 350 milliseconds. Freq: 1000Hz.
1ukp Two times the Above.

Hi there, M... First of all, I know precisely what you're talking about. I used to mess around with those PhoneMan programs on the Commodore 64 about a decade ago. Man,

those were the days! Sometimes, I feel like I'd give anything to live back in the 80's because I had SO MUCH FUN. Ok, here's an answer straight out of the Hacker FAQ concerning the ABCD touch tones: These are extensions to the standard touch-tones (0-9, *, #) which originated with the U.S. military's Autovon phone network. The original names of these keys were FO (Flash Override), F (Flash), I (Immediate), and P (Priority). The various priority levels established calls with varying degrees of immediacy, terminating other conversations on the network if necessary. FO was the greatest priority, normally reserved for the President or very high ranking officials. P had a lesser priority, but still took precedence over calls that were placed without any priority established. Today, the tones are commonly referred to as the A, B, C and D tones respectively; each of these tones use 1633 Hz as their high tone. These are found mainly used in special applications such as amateur radio repeaters for their signaling and control. Modems and touch tone circuits tend to include the A, B, C and D tones as well. These tones have not been used for general public service, and it would take years before these tones could be used in such things as customer information lines; such services would have to be compatible with the existing 12-button touch tone sets in any case.

An interesting note: most modems will recreate these touch tones... instead of numbers, use ABCD... see if it works on your modem.. Kind of useful for your touch tone projects if you're worried about people using their phones to trigger your devices. Think about it. While we're on the topic, let's get some other info out in the open here..

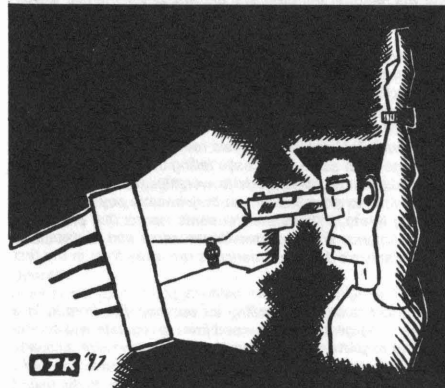

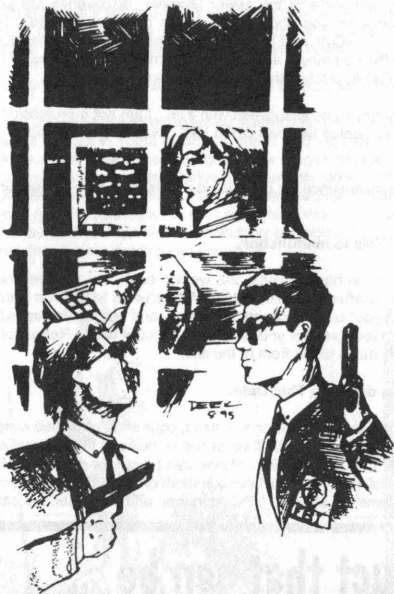

It's a number (one of many) that telco's use for line verification and different line numbers, pairs and site IDs, like 800-696-4225 in which in this case you enter your area code for line verification. Another cool number is Ameritech's 800/888 raspborg ID check. Let's say you have a friend who has this 800 or 888 voice mail or 800/888 attached to their home number, he says "you can't take my eight down!" and you say "oh yeah!" so you call up the raspborg ID service, enter his 800/888 number and it spits back the line carrier and a 800 number to call to tear it down. This is great for tearing down AOL customer service numbers. Anyway...

FEARS, FIXES, AND SOME IDEAS ABOUT 2000

We've all heard it by now. "Revenge of the COBOL Kids." "Old Programmers' Retirement Fund." A few more, I'm sure. The media freaks, of course, are having a field day. "The 2000 Disaster." "Millennial Meltdown." "The Year 2000 Bug--The End of Civilization?" And more that make the technically literate gag.

Those of us who read BLACKLISTED know the problem--old code was dated with a 2-digit year instead of a 4-digit year, to save hideously expensive memory. It made sense, it was a good idea, and WHO WOULD HAVE THOUGHT that Commodore Grace Hopper's ancient language for programming database and formulaic commands into old, big, slow mainframes would still be in use today? Who would have thought, in 1953, that the "00" upcoming IN A MERE 47 YEARS would be read as 1900 and not 2000. Did anyone ever have the idea, up until very recently, that this could be the most expensive error in the history of the planet?

In some ways, this is incredible hype. Yes, it is a problem, a big one, but hardware upgrades, software upgrades, and the now well-known COBOL Programmers' Revenge--those consultants and programmers fixing every single line of the soon-to-be offending code--will fix the vast majority of the problems. Some systems, which could be seriously or catastrophically affected, will merely be replaced on time or a bit early. Those systems include CAT and PET scanners in hospitals, as well as hospital and clinic radiotherapy treatments, control systems for nuclear power plants, the submarine, missile launch and missile guidance, and satellite command and controls systems managed by the Pentagon, and air traffic control computer systems. Some systems, probably the most capital expansive of all affected items (that we now know of), will be replaced: the servers, workstations, and high-end PCS that power so much of our economy. As the life spans of such items is so low--far shorter than, say, a vehicle, a building, or even a corporate or shared satellite. Every one or two or three years, throw 'em out and start over. Well, THAT part is easy, at least.

There WILL be some problems affecting us at the consumer level, and some of the newer problem discoveries are just maddening. I'll discuss those new ones that I'm familiar with, and warn you about some which may get ignored. Do remember, just because we now know of the Y2K problem, we DO NOT KNOW all of the manifestations of the problems. Just too many parts of our society are computer-driven. Just too many of the computers are completely embedded systems. Too many of us technically-employed are out making money, not looking for old glitches that COULD turn into new glitches.

What I am about to tell you is not any solution to the various line code problems associated with Y2K. I am not a professional programmer, but I'll tell you some tricks to lessen the impact ON YOU, lighten the load of the Y2K "events" about to occur to us, ready or not.

You will have before you several problem areas; items of severe inconvenience. It is up to you to keep the life-threatening ones--if they're even there--at bay.

1. Automated Teller Machines: Security features may cause ATMs to malfunction.

The easiest solution here is probably the best. Have sufficient cash on hand (maybe 2-3 weeks' cash), by no later than December 28, 1999, so that you won't need to hit the ATM on or shortly after 01/01/2000 (hereafter referred to as That Date). Well before That Date, have hardcopy printouts, not just disk files, of your bank accounts, balances, and automatic deposits. So if your bank makes insufficient preparations for Y2K, you have paper proof of your standing, account wise. Remember, those who have such proof in a possible problem scenario will literally move to the front of the line.

2. Buying groceries: Modern features at a supermarket may go down on That Date.

For those of us who have lived in South Florida for some time, we know to have a hurricane stash, consisting of bottled water, 10 days or so supply of canned/package foods (nothing that requires refrigeration), fill up all the vehicles at the gas station, fresh batteries for the flashlights and boomboxes, and about \$100.00 in one dollar bills. Power can be out for days at a time (like from hurricanes Andrew, David, Donna, etc). So, come October of 1999, we won't put our stash of canned foods into the regular food shelf and eat them. We'll save them for whatever problems the servers, UPC scanners, and computerized cash

registers at the local food stores may encounter with Y2K. They may be ready. If not, are you prepared to go on a serious diet? After the summer of 1992, my wife and I have had food and cash readily secured; an "insurrection stash" as my wife calls it. By being prepared for large circular storms from the Caribbean and political or racial disturbances coming our way from Miami, I have assessed we're in pretty good shape for this problem, should it materialize on That Date.

3. Using elevators: Programmed safety features may cripple them.

One of the very recently discovered problems about That Date is the effect it will have on pre-programmed safety features in modern electronically controlled elevators. When an elevator has a certain number of operational hours, or it is past a certain date, it automatically goes to the "service floor" (usually the basement), opens its front (and if present, rear) doors, and turns itself off and will not budge until it is reset upon being serviced. Now, this is a great safety feature—I do not want to be in a moving, unserviced, unrepared elevator. However, I don't want to be in a building where the elevators control units "know" they are due for servicing, go to the basement, and await the service crew. According to "an expert" on NPR a few months ago, the United States has over 50,000 electronic elevators which will have this problem unless corrected. I am not able to confirm this number, but that's a whole bunch of not-moving people if that number is remotely close. The same person said Japan and Europe each had almost as many elevators, which will also not be moving much on That Date if the Y2K problem is not fixed. So, try to avoid elevators, starting on New Years Eve day. All that day, and, all the next day. Know where those stairwells are!

4. Personal Computers Will MY Data Die?

I am preparing two backups of my systems. If that sounds a bit paranoid, consider the way I plan on doing them. The first backup will be a straight backup, on either disks or zip, depending on what I have by Summertime 1999. I will make no changes, just a complete backup of my hard drives. Then, the other backup, which will be another complete backup of my hard drives, EXCEPT in this case I will first reset the system calendars to 01/01/91 (don't ask me how I know, but WIN 95 will support this date). My reason for this: my first backups will be dated late 1999, too close to Y2K if there is a problem in my desktop systems (and I'll tell you: I've been ASSURED, there is no problem with any of my systems—I'm still making TWO backups). A few extra bucks and an extra hour per system (probably less), and I'm safe with my data. Are you?

5. Bank Balances Will My Deposit Disappear into Cyberspace?

This one is probably the easiest to remedy, and most likely the one the most people will fumble. Do you keep AT LEAST 12 months worth of bank statements? Start now. Two full years is better, and do have all of 1999's pay stubs or deposit receipts. While this is one of the least likely events to hit an individual, this can be a near disaster in an age of electronic direct deposits, and automatic debits for things like mortgage or rent, auto payments or student loans. Banks really SEEM to be up on this problem, so it's not a GREAT worry, but one to pay attention to. Remember, there are several organizations involved: the failure of one can bring down your finances, at least temporarily. Banks, employers, and automatic debtors are all in the loop on this —you cannot just trust them to get everything of YOURS right.

6. My Investments/Pension It Won't Disappear—Will It?

If you are like millions of under-40 Americans, you are heavily involved in your own pension, IF you have one at all. An IRA means you put in 100% of what is there, a 401(k) means you have to contribute some money for your employer to contribute. As we all are aware, the days of 30-year employment and a fully funded corporate pension are gone with the wind. This puts a financial burden on the worker to ensure his retirement fund, to be sure, but even more, it puts the responsibility of tracking your pension-to-be COMPLETELY on each worker. I'll assume you keep at least quarterly statements in a notebook or folder. If not, get started the month you read this article—you'll have enough lead time before That Date. A file of statements showing your automatic deposits and matching contributions (if you're so lucky) will ensure you of a visible, provable track record, ensuring you are credited for your due.

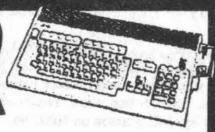

Wal~mart Phones

Have you ever walked into a store like Caldor or Target, and see one of the employee's on the phone? Ever wonder what it would be like to phreak the phone system in one of those stores? Well, wonder no further, In this article I will attempt to explain to you how the phones at your local Wal~Mart work and hope to answer any questions that you might have.

First off, it's important to know the type of phone that you'll be dealing with. Most Wal~Mart's use a **Lucent Technologies** or **AT&T model MLX-100** or **8102**. For those of you that might happen to see a **Bell Labs**, phone, don't panic, **Bell Labs**, is the same as **Lucent**.

Lets start with the **AT&T 8102**, This is your standard non-display type phone with a series of 10 buttons arranged in pairs of two's. These are your programable buttons. They usually contain three outside lines, and the rest are usually just diffrent departments, or if your really lucky one of them is for the paging system. (I'll explain more about that in a minute.)

The three lines that are for outside calls on these phones are for incoming only. Most of them have a block on the lines that won't allow you to get an outside dial tone. But will allow you to pick up an outside call. But, you can dial **911** just by picking up and hitting **9** for a dial tone then hit **911**.

The next set of buttons you'll see, are three in a straight line. These are your **flash**, **redial**, and **hold**. Keep in mind that the **flash** button does not give you enough time to truely **flash** the reciver, so almost always this has to be done manually.

After your **hold** button row, is a normal numeric touch tone pad, for you to dial the diffrent extentions on. All the extentions in every Wal~Mart are the same no matter where you go. Some of which are as follows.

Front Courtsiy Desk -Extention 150

Electronics - 105

Layaway - 181

Mens - 123

Operator - 0 or 129 for the fitting room.

Which brings me to my next point. *The Operator*. She is located in the ladies fitting room, she has the best phone in the whole store, so if you want to phreak it you have to get through her.

Inter-store communication is possible, simply by picking up **any** house phone and dialing, the one of the following numbers.

9-1-700-701-xxxx

9-1-700-707-xxxx

xxxx stand s for the store's number that you are calling, this is the number of the store in order of when it was built, **not** the phone number. Example store **2046** was built before store **2155** so if you wanted to call store **2155** then **xxxx** would be **2155**. (Get it?) Any way, the next step will be the *store code*, you must enter this to complete the call. This is in most cases the store number, that you are calling from. Example if you dial **1-700-707-2355**, it will ask you to enter your code if the store you are calling from is store number **0042** then **0042** is the code you would enter to complete the call.

Ok, that just about covers the **model 8102**, now on to the good stuff, **model MLX-100**. **MLX-100** has all the same features but it looks totally diffrent. First noticable thing you'll see is that it has a display screen. Watch out for this type of phone, it will tell who ever is on it, where you are calling from.

Directly under the screen you will see four buttons (black.) Directly below each of them are another set of four buttons, **home**, **inspect**, **menu** and **more**. Each of these buttons does a diffrent specialized function which is of no relevance to this article. Below it , you will see a set of 10 black buttons, this is the good stuff.

There are as follows, left side, **paging**, **privacy**, **blank**, **intercom voice**, and **intercom ring**. The right side has **pick up line one**, **pick up line two**, **pick up line three**, followed by two blank buttons. Lets start with the **paging** button. This button is pre-programed by the store to dial **#96**, this is the extention on the phones that is used by everyone to notify other employee's or customers of whats going on. But, please note this is not an extention. Unlike K-Mart who's

paging system is simply an extension on the phones like a department, Wal-Mart's are not. It's uses the # for a reason, so as not to be confused with any other department that has a 96 in it. This is the only way to page on any of the phones. If the phone you have doesn't have a paging button, then you must manually dial #96 to activate the P.A.

Privacy, this is used to keep your calls private and not have anyone pick up the line you're using, and listen in on your calls. If the **Privacy** light is not on, you do not have a secure call.

Blank these are the non-programmed buttons. Pressing these will do nothing. However try your luck anyway some of them are programmed with different departments, or other stores.

Intercom voice, this feature allows you to speak to a person in another room (they must also have a **MLX-100**) using the speaker phone.

Intercom Ring, same as the intercom voice, but used as a prelude to the **Intercom Voice**, to see if they are available.

Pickup line's 1-3, these buttons are pretty much self-explanatory, if you're receiving an outside call you must pick up one of the three that the call is on.

Now, on some of the **MLX-100**'s there is no way to get an outside line without putting in a 3-digit code. The code is usually **Feature 8xx** then you must pick up a free line. This is the only way on the "non-essential" phones to get an outside line. But, in some cases the only type of line you can get is an inter-store line, no matter what. Some of the phones (if you're lucky enough to get in to the back of the store) don't even need a code to get an outside line. Just simply pick up the phone, choose an outside line and dial away.

Ok, so now I've covered most of the buttons on this type of phone, we will move on to the final group of buttons. They are:

Feature, HFAI, mute, speaker, transfer, confrence, drop, hold.

Let's start with **feature**. This in conjunction with the code **8xx**, allows you to pick up an outside line, the **xx**, can be any set of numbers that your heart desires, each one is supposed to be assigned to a different department head so as to keep track as to who is making what calls, and to where.

HFAI, I have no idea what this does, I can't seem to figure out what purpose it serves, so we will disregard it for now.

Mute, speaker, hold are all self-explanatory.

Transfer, this allows you to obviously transfer calls to other areas, of the store, simply by hitting transfer and then dialing the dept number, you will transfer the call.

Confrence, allows you to make conference calls, (similar to that of a party line).

Drop, drops a call once it's placed on hold.

One last thing before I go, 800 numbers. Most of them are ok to dial on this type of phone, but some of them won't go through. I can only speculate that the 800 number is one that allows return billing for services, (such as some tech supports, and phone sex lines). 900 numbers are strictly forbidden and won't work so don't even try.

So wrapping everything up now, we see the ins and outs of the Wal-Mart phone system. So next time you're in a Wal-Mart and a new employee is having trouble with the phones, simply pull out this article and you'll be able to get the job done. Happy Hacking!



Part III

INDUSTRIAL SOCIETY AND ITS FUTURE

OVERSOCIALIZATION

24. Psychologists use the term "socialization" to designate the process by which children are trained to think and act as society demands. A person is said to be well socialized if he believes in and obeys the moral code of his society and fits in well as a functioning part of that society. It may seem senseless to say that many leftists are over-socialized, since the leftist is perceived as a rebel. Nevertheless, the position can be defended. Many leftists are not such rebels as they seem.

25. The moral code of our society is so demanding that no one can think, feel and act in a completely moral way. For example, we are not supposed to hate anyone, yet almost everyone hates somebody at some time or other, whether he admits it to himself or not. Some people are so highly socialized that the attempt to think, feel and act morally imposes a severe burden on them. In order to avoid feelings of guilt, they continually have to deceive themselves about their own motives and find moral explanations for feelings and actions that in reality have a non-moral origin. We use the term "oversocialized" to describe such people. [2]

26. Oversocialization can lead to low self-esteem, a sense of powerlessness, defeatism, guilt, etc. One of the most important means by which our society socializes children is by making them feel ashamed of behavior or speech that is contrary to society's expectations. If this is overdone, or if a particular child is especially susceptible to such feelings, he ends by feeling ashamed of HIMSELF. Moreover the thought and the behavior of the oversocialized person are more restricted by society's expectations than are those of the lightly socialized person. The majority of people engage in a significant amount of naughty behavior. They lie, they commit petty thefts, they break traffic laws, they goof off at work, they hate someone, they say spiteful things or they use some underhanded trick to get ahead of the other guy. The oversocialized person cannot do these things, or if he does do them he generates in himself a sense of shame and self-hatred. The oversocialized person cannot even experience, without guilt, thoughts or feelings that are contrary to the accepted morality; he cannot think "unclean" thoughts. And socialization is not just a matter of morality; we are socialized to confirm to many norms of behavior that do not fall under the heading of morality. Thus the oversocialized person is kept on a psychological leash and spends his life running on rails that society has laid down for him. In many oversocialized people this results in a sense of constraint and powerlessness that can be a severe hardship. We suggest that oversocialization is among the more serious cruelties that human beings inflict on one another.

27. We argue that a very important and influential segment of the modern left is oversocialized and that their oversocialization is of great importance in determining the direction of modern leftism. Leftists of the oversocialized type tend to be intellectuals or members of the upper-middle class. Notice that university intellectuals (3) constitute the most highly socialized segment of our society and also the most left-wing segment.

28. The leftist of the oversocialized type tries to get off his psychological leash and assert his autonomy by rebelling. But usually he is not strong enough to rebel against the most basic values of society. Generally speaking, the goals of today's leftists are NOT in conflict with the accepted morality. On the contrary, the left takes an accepted moral principle, adopts it as its own, and then accuses mainstream society of violating that principle. Examples: racial equality, equality of the sexes, helping poor people, peace as opposed to war, nonviolence generally, freedom of expression, kindness to animals. More fundamentally, the duty of the individual to serve society and the duty of society to take care of the individual. All these have been deeply rooted values of our society (or at least of its middle and upper classes (4) for a long time. These values are explicitly or implicitly expressed or presupposed in most of the material presented to us by the mainstream communications media and the educational system. Leftists, especially those of the oversocialized type, usually do not rebel against these principles but justify their hostility to society by claiming (with some degree of truth) that society is not living up to these principles.

29. Here is an illustration of the way in which the oversocialized leftist shows his real attachment to the conventional attitudes of our society while pretending to be in rebellion against it. Many leftists push for affirmative action, for moving black people into high-prestige jobs, for improved education in black schools and more money for such schools; the way of life of the black "underclass" they regard as a social disgrace. They want to integrate the black man into the system, make him a business executive, a lawyer, a scientist just like upper-middle-class white people. The leftists will reply that the last thing they want is to make the black man into a copy of the white man; instead, they want to preserve African American culture. But in what does this preservation of African American culture consist? It can hardly consist in anything more than eating black-style food, listening to black-style music, wearing black-style clothing and going to a black-style church or mosque. In other words, it can express itself only in superficial matters. In all ESSENTIAL respects more leftists of the oversocialized type want to make the black man conform to white, middle-class ideals. They want to make him study technical subjects, become an executive or a scientist, spend his life climbing the status ladder to prove that black people are as good as white. They want to make black fathers "responsible," they want black gangs to become nonviolent, etc. But these are exactly the values of the industrial-technological system. The system couldn't care less what kind of music a man listens to, what kind of clothes he wears or what religion he believes in as long as he studies in school, holds a respectable job, climbs the status ladder, is a "responsible" parent, is nonviolent and so forth. In effect, however much he may deny it, the oversocialized leftist wants to integrate the black man into the system and make him adopt its values.

PIRATE RADIO SURVIVAL GUIDE

PROVIDED BY GROUP 42

QRM

These 3 very important letters are taken from the Amateur Radio "Q Codes" and literally mean "Is my transmission being interfered with?" or "Your transmission is being interfered with." The source of the interference is typically MAN made. QRN means the same thing except the source of the interference comes from NATURAL causes.

While broadcasting and another of your radio neighbors decides to use the frequency you have chosen, You are being QRM'd. This is unfortunate but since you are not supposed to be there anyway, just move to another frequency!

While broadcasting and YOUR transmitter is QRming your neighbors TV, Radio, Stereo, Phone, etc. you have a SERIOUS PROBLEM! Do not ignore it! From what little information on pirate busts I have obtained, MOST seem to be related to unresolved interference problems! It is in your best interests to take a active approach to solving your QRM problem. If you do not solve QRM problems, the FCC WILL take steps to solve the problem! Since we know what their solution is, I am going to present easier, less costly, painless ways to solve your problem.

START WITH YOUR OWN GEAR - Perhaps the most overlooked part of any station is a good ground system. See the chapter on Station Ground Systems.

Use a low-pass filter on your transmitter. This is a passive device that you insert into the feedline between the Transmitter and Antenna. While not difficult to build, for a beginner, I would recommend purchasing one. You can expect to pay between \$25 to \$75 for a GOOD low pass filter. They are rated in Watts so you need to know much power your transmitter runs so you won't get one that is to "small". Some of the better units are tuneable, which will help to knock down harmonic interference greatly. Any Ham Radio Equipment catalog will carry several Low Pass filters, so they are not hard to find.

While more advanced, your Transmitters Parasitic Suppressors could be "smoked". Your Transmitter will appear to operate normally, as it should, if your suppressors are fried but will generate more harmonic type QRM than is normal. See Figure 1 for a schematic of a parasitic suppressor. Usually mistuning a transmitter is enough to burn out the resistor in a suppressor and since the resistor is in parallel with the coil, you cannot easily tell if the resistor is fried with out un-soldering one side of the coil. If the resistor looks like a charcoal cylinder, it's pretty safe to assume it's bad. "Hey, my Transmitter doesn't use parasitic suppressors!", find somebody to add them. It is not terribly difficult and can be done by anyone who knows how to solder and wind some wire around a resistor! Learn how to properly tune your transmitter! If your transmitter is not tuned correctly you could be generating interference. Read and study your manual!

Do not "over-drive" the transmitter! This will generate QRM and also make your signal wide, splatter, and sound distorted! It is easy to over-drive any Transmitter. The best way to check if your pushing your transmitter to hard is to listen to yourself off the air. You may find that you need to put some distance between yourself and the transmitter to keep from overloading your receivers front end into distorting. This is simple to rectify, simply reduce the "Audio Gain" on the transmitter or reduce the line level audio feeding the transmitter until your signal's audio clears up.

Use a properly constructed, RESONANT, antenna! See the chapter on antennas for more information. You could find that it is your choice of an antenna that is giving you problems.

Watch the TV in your house to see if you are interfering with it. Check your phone, stereo, etc. and notice any interference problems, if any. This will help to determine if you are really at fault. It is always convincing if you can demonstrate that you do not interfere with reception in your own home.

"I'VE DONE ALL THIS AND I STILL QRM MY NEIGHBORS!" - This is where the game can get interesting and you need to have your "cover story" well rehearsed in order not to "tip off" anyone to ILLEGAL activities! If you have any experience with phone phreaking, the term "Social Engineering" will mean a great deal to you. Should you not know what "Social Engineering" is, I will try to tell you what it means in general and how to apply it to dealings with neighbors.

Social Engineering is the art or getting information out of people without raising their suspicions. Sounds easy doesn't it? Believe it or not, in practice it is quite easy to use.

Remember, none of the following information will do you ANY good if your neighbor and yourself are already on bad terms! The damage has already been done and you should concentrate your efforts on the preceding information! It is in your best interests to stay on friendly terms with your neighbor because He or She can very easily end your pirate career with unpleasant results!

RF Feedback

No matter what you do, RF Feedback WILL rear its ugly head in one form or another at your station. Perhaps the only way to avoid RF Feedback is to use a Studio To Transmitter link (STL) to get your transmitter away from the rest of the station. Don't worry, you won't have to take that extreme! RF Feedback can be cured 99.99% of the time. All it takes is a little understanding of the problem and some tried and true cures.

RF Feedback is caused by being in close proximity to a source of High Level RF Energy. It doesn't mean that your equipment is really at fault, other than being too darn close! Anything electronic is a potential victim for RF Feedback and it will be quite apparent when RF Feedback is present!

The simplest cure for RF Feedback is the RF Choke. A RF Choke is a coil wrapped around a ferrite core to impede the flow of RF Energy. Radio Shack manufactures a snap on unit, it works well. A cheaper, and sometimes just as effective, alternative is the ferrite rod from an old AM Radio's loopstick antenna. Whatever you can come up with should be used. The key to using RF Chokes is in the amount of turns you can use: The more the better. Places to use chokes are on the AC Power cords and ALL Audio Cables. Electrical tape helps keeps the

wraps in place.

Another simple way to reduce the possibility of RF feedback is to make sure that any patch cords or audio cables are high quality shielded cables. Cheap cables are more trouble than they are worth. Also try plugging your transmitter and audio source into different AC outlets.

If you still suffer from RF Feedback problems, the next step is to install Bypass Capacitors into the effected equipment. I suggest using .01 uF Ceramic Disc capacitors rated at 1000 volts. To properly de-RF a piece of gear, you need to concentrate your efforts in two places. First, the Power Supply of the unit. Typically, RF will enter via the AC line cord and get into the power supply affecting everything else. Open the unit, MAKE SURE IT'S UNPLUGGED! Locate the power supply, if you don't know what a power supply looks like you might want to find someone who does. Places to install bypass capacitors are on each side of the AC line cord to ground, across the Secondary windings of the transformer to ground and finally, across the rectifiers to ground. This should clear up any RF getting into the power supply.

Should you still suffer, the next step is to bypass all the line in and out connectors on the gear. Simply connect your capacitor from the Hot Side (Center Conductor) to the chassis ground. Also make sure the equipment is properly grounded in the first place! Do this for all the connectors, regardless if they are used or not. And finally, don't forget about your speaker connections, they might be bypassed as well since speaker wire tends to act as an antenna!

If you try all this and you still have problems, try moving the transmitter or antenna farther away, sometimes a few feet can make all the difference in the world. You may even have to resort to trying another tape deck, some cheap tape decks are impossible to protect from feedback.

Transmitters

One of your most important and difficult investments will be the purchase of a transmitter. While it is possible to build your own, it is much easier and usually cheaper to purchase a transmitter. In this chapter we will discuss what transmitters are, how they operate and what you need to know when buying a transmitter.

"What is a transmitter?" Good question. A transmitter is a device that converts AC or DC energy to RF energy. By itself, RF energy doesn't do us much good, so a transmitter also requires audio information to "Modulate" the RF energy it generates. The modulated RF energy is coupled into an antenna to be dispersed into the ionosphere. Now that you know what a transmitter does, we're going to discuss variations and capabilities that can be found when looking for your dream rig.

Controlling The Frequency

In the beginning there was Crystal Control. This means you must supply a crystal cut or ground for a specific frequency to operate on that frequency. If you wanted to operate on 7415 Khz, then with a crystal controlled transmitter you would have to supply a crystal cut or ground for 7415 Khz. You could NOT operate on 7465 Khz unless you supply ANOTHER crystal for 7465 Khz. As you can see, if you want to remain flexible in your frequency options, crystal controlled transmitters are not recommended unless you can afford around \$10 per crystal! One advantage that crystal control does have is that the transmitter will NOT "drift" or if it does drift, it will be very little. Usually drift is not a problem if you let your transmitter "warm up" for a couple of hours before using it. Since active frequencies change often, it's hard to "Keep Up" with a crystal controlled rig.

Variable Frequency Oscillator - Sounds like something right out of a Star Trek episode. This is the next step up from "Crystal Control". A transmitter that comes equipped with a VFO or can use an external VFO gives you freedom to operate on any frequency that it covers and where the transmitter is able to tune up. Most VFO's will cover the ham bands in 500 Khz segments and this can be utilized by the pirate to get outside the ham bands. It also allows for moving your frequency at a moments notice. The ONLY disadvantage to using a VFO is that they are more prone to drift. If you let your gear "warm up" drift is usually not a problem. With the newer synthesized types of VFOs drift is practically nonexistent.

Now You're Talkin'

By now, you might be familiar with some terms that describe types of modulation. The most used by broadcasters is Amplitude Modulation or simply referred to as AM. Other types include Single Side Band (SSB) which means Upper Side Band (USB) or Lower Side Band (LSB), Double Side Band (DSB) and even more exotic are Frequency Modulation (FM), Phase Modulation (PM). For now, the

NOKIA 2160 SERIES CELLULAR TELEPHONE NAM PROGRAMMING INSTRUCTIONS

All Nokia 2160 cellular telephones are capable of supporting authentication. There are two authenticated versions of the 2160. This document provides information necessary to program the version that contains a Default A-Key in NAM1. The A-Key can be reprogrammed using this menu sequence, or by referring to the industry specification TSB-50. There are two methods to program the NAM. Both the 'Easy NAM' and the 'Complete' methods are described below. The clear key can be used to correct mistakes.

1. Turn On Phone and Enter Programming Access Code (*#639#)
2. Enter the 10 Digit Area Code and Phone Number and Press The Send Key (or the 'OK' softkey in display)
3. Enter System ID Code (SID) Supplied by Cellular Service Provider (1-5 Digit SID) and Press The Send (or 'OK') Key
Optional Settings are Language and Lock Code (See below)
Programming Is Completed
Phone Automatically Powers Off and Then Back On

FIELD TEST:

The FIELD TEST MODE is used to investigate how the phone is reacting to the cellular system. The FIELD TEST information covers signal strength, battery charging status, cellular state and encryption status. The information is organized to display information relating to Analog Control Channels, Digital Control Channels, Analog Voice Channels, and Digital Voice channels. All the information provided in the FIELD TEST display is in accordance with IS-136.

To activate the FIELD TEST mode you must be in NAM programming. Instructions for entering NAM programming are on the opposite side of this page. Use the following steps to enable the FIELD TEST mode.

From the Main Menu use the scroll key to display the "FIELD TEST" menu and press the [Select] softkey. Use the key to select Enable and press the softkey [OK]. A second option is available to enable the field test display with backlighting constantly illuminated while connected to a car kit.

Turn the 2160 off then back on. Once the power up self test is complete, the FIELD TEST display will begin automatically. Scroll through the different displays using the scroll key.

To disable the FIELD TEST mode. Return to NAM programming and disable the function under the FIELD TEST menu.

PROGRAMMING PSIDS AND RSIDS:

The Nokia 2160 provides the option to program Private (PSIDs) and Residential (RSIDs) System ID's as prescribed by IS-136. The other 10 locations are reserved to ensure locations are available for automatic programming. Using the NAM programming menu to program the PSID / RSID is just one of several ways that this information can be programmed. The phone also supports automatic programming of the PSID / RSID values via registration from a Public & Private system or via Over the Air Programming. Follow these instructions to program the PSID / RSID lists.

1. Enter the NAM programming menu and select NAM 1 (or the desired NAM). (Note: PSID / RSID is currently only available in the NAM 1 location. PSID / RSID is included in NAM 2 and 3 for future use.)

RESTORE OUR COMMON LAW

In society we have many types of law. We have God's law which is scriptural law and spiritual law. Then we have natural law. Common law is the merging of God's law and natural law. Common law is also connected to common sense. Common law has been codified in the Declaration of Independence, Articles of Confederation, The Constitution for the united States of America and the original state constitutions. The Constitution also gave the federal government a limited area where Congress has the power of exclusive legislation in all cases whatsoever and where it can ignore constitutional and common law restrictions. The area it can have exclusive legislation is Washington, D.C., U.S. Territories, Enclaves and Possessions. The law in this area is called Admiralty Law and is codified in what is called the Uniform Commercial Code (U.C.C.). Amendment 13 is really Amendment 14. Amendment 13 was passed in 1819 and disappeared from the Constitution in the 1860's.

All the amendments through the anti-slavery amendments are common law amendments. All the amendments since the so-called 14th amendment are part of the Uniform Commercial Code. The 14th Amendment did not incorporate any part of the common law bill of rights and so 14th amendment U.S. citizens have no access to the bill of rights or the common law. To access the common law one has to be a Article 4, Section 2 clause 1 sovereign Citizen of the several states. The U.C.C. supplants but does not abolish the common law. One can exit the admiralty U.C.C. by invoking the remedy found in U.C.C. 1-207 and 1-103.6 which reserves your common law rights without prejudice.

The common law only has two laws in it. Law 1 behave yourself and do not violate the rights of others which is essentially the right to life, liberty and the pursuit of happiness. Law 2 when you enter a contract knowingly and with full understanding of its consequences and alternatives, honor those contracts or be liable to the consequences for violation. Justice is in the common law and not in Admiralty Law. The law for the 14th amendment U.S. citizen is Admiralty Law. The law for the sovereign Citizen of the several states is the common law. The freedom of our society requires restoration of the common law. Restore and exercise the common law and constitutional law by choosing to be a sovereign Citizen of the several states again. Article 4, Section 2, Clause 1 Citizens of the several states are because of this, secondly become Citizens of these united States of America. How to become a sovereign Citizen is the basis of another article in a later issue.

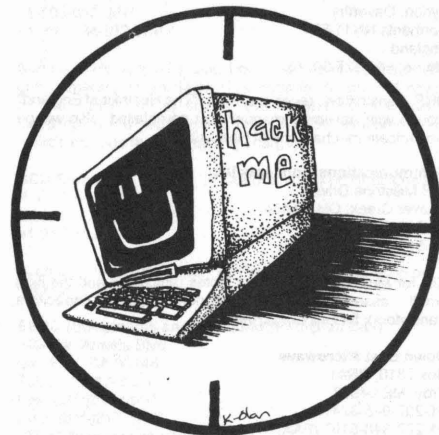

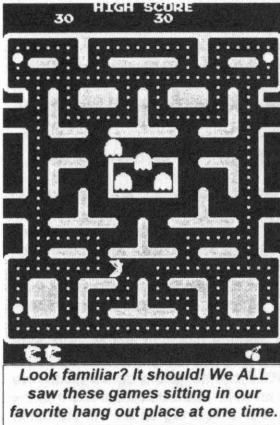

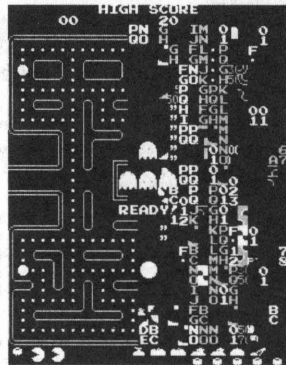


Pac Man and Ms. Pac Man are probably THE most famous arcade game in the history of games. Let us take a technical look at the Pac Man game board.

Pac Man used an interesting power supply in the same format as Galaxian in the form that it was on the CPU board. IT used a 4 pin voltage regular and a heatsinked series pass transistor to take 7 volts AC to the 5 volts needed. In later years, some operators would bypass this onboard power supply to connect to a regular switching power supply.

Pac Man used a single CPU, a 1 MHz Z80. The program for Pac Man was 8K, and Ms. Pac Man used a satellite CPU which had 12K of program. Either way, the whole board was controlled from this CPU setup.

The inputs from the joystick fed into a series of 74367 chips which fed into the data bus. The graphics system was a dual system of a character background and sprite objects. Graphics ROM was 8K for either game. The graphics was 16 color palette into 256 color TV output.



This is a screen shot of one of the more common bugs known as "255 Split" After so many levels, this is what ya got! Neato, huh?

The sound system used a slightly bizarre waveform system with dual 16 byte RAM chips (7489). One 7489 would clock out into an A/D as a reference waveform, and the other 7489 RAM would modulate the reference waveforms and form the sound waveform. The sound was then sent to an LM1877 sound amplifier. Please note that this same sound system was also used in Galaxian and Galaga. Galaga also used another boom circuit.

It is interesting to note that Pac Man was originally programmed by Toro Iwatsani for Namco. Back then, the game was known as Puckman in Japan, the name was changed because a one letter change would make it sort of obscene :). It is also interesting to note that Ms. Pac Man was NOT created by Namco or Midway, it was a pirate version of Pac Man created by a company called GCI (General Computers Inc. of Massachusetts). GCI had been previously sued by Atari for a speedup kit for Missile Command called Super Missile Attack. Atari settled this case with the condition that GCI create two games for Atari. The two games were Food Fight and Quantum. Both were the first 68000 games for Atari, and stunningly original games.

There were tons of silly little speedups made for Pac Man. The Popeye graphics were loads of fun, and there was even one using the Pengo characters. Midway sued lots of people, left and right over these speedup kits. They had reason to, as this was THE biggest arcade game run of a single game in history, with over 350,000 games sold. (this is compared to the Neo Geo system which sold over 1.5 million boards)...

Since Pac Man was so incredibly popular, along came modifications and hacks to the game. Many versions of the little gobbling creature were made. Among them were:

- Pac Man (the original, of course)
- Ms Pac Man (conversion done with an auxiliary board & 2 new EPROM's at locations 5E and 5F)
- Pac Man Plus (Conversion using auxiliary board (epoxy coated), 6 new EPROM's & 2 new color proms 4A, 7F)
- Jump shot (Conversion using auxiliary board (epoxy coated), 6 new EPROM's & 2 new color proms 4A, 7F)
- Shoot the Bull (Conversion using auxiliary board (epoxy coated), 6 new EPROM's & 2 new color proms 4A, 7F)
- Piranha
- Driving Force (Conversion requiring additional kludge board & severe hacking)
- Eyes?
- Make Trax (This game may run, Pac Man can be hacked to run on a Make Trax board. See Crush Roller)
- Lizard Wizard (Required auxiliary board (epoxy coated), 6 new EPROM's & 2 new color proms 4A, 7F)
- The Glob & Super Glob (auxiliary board- 2 2732 EPROMs 1 PAL & several TTL chips)
- Eeek!?
- Pinky's Maze ?? "The new game intros new characters and a choice of 16 different mazes" I have an ad for this conversion kit but do not know anything about it nor have I ever heard anything about it....
- Penta/Pengo? Will a decrypted version of Pengo run on Pac Man??
- Beastie Feasties runs on a The Glob PCB

Some hacks were made to actually run multiple games. To choose which game you wanted to play, you'd either make some changes to some dip switches on the boardset or, the more "slick" hacks allowed you to change between games using the controls on the control panel. 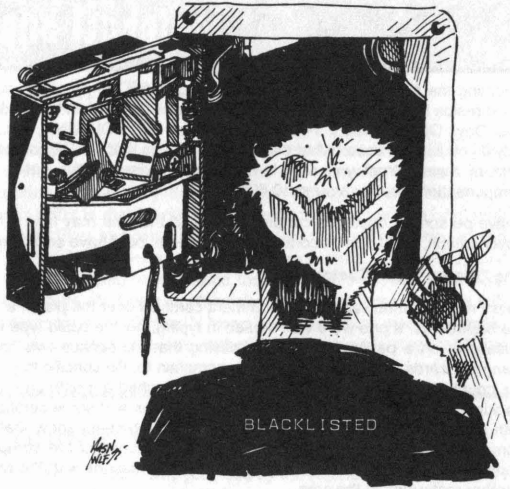

CAR INSURANCE?

In most states you have to show proof of car insurance before you can get auto tags. California has Smog Inspection for all cars made after 1965. Texas has inspection for all cars regardless of the year. In most states if you let your car insurance lapse they write you a letter telling you to turn your plates in or even worse. Currently 4 states have no insurance requirement what-so-ever. They are Alabama, Mississippi Tennessee, and New Hampshire.

Of the four, however Alabama is particularly unique. Alabama doesn't require car insurance or inspection or title on all vehicles manufactured in 1975 and back. You simply show up at the window and say 'I want to put this vehicle in my name'. They don't even go out into the parking lot and see if you've even got a vehicle! To make this goes smoothly it's best to go to rural DMV offices such as Bay Minette and Foley. Simply give them the address of the nearest homeless shelter and \$38 (This'll go a lot quicker if you buy their specialty plate) and in 5 minutes you'll walk out the door with new plates. No hassle!

In Alabama with all vehicles 25+ years old, you simply walk in the door and hand them \$10 and they hand you a black plate that never expires. No title or other paperwork is required. What all this really means is that if someone had a junker, a clunker, or a backyard bunker that couldn't pass inspection in his home state, he could simple go to Alabama to get plates. This also means that if one lived in an old pickup or van and just wanted it set up somewhere while they lived in they would not have to worry about vehicle insurance. In many states if you park a vehicle for any reason and let the insurance lapse they will make you turn in the plates.

Here is an example of this principle applied in real life. An old man in West Florida drives in an old 68 Chevy. He can't afford car insurance so he just goes about 100 miles north into a rural Alabama country gets an antique plate. He is charged a one time fee of \$10. Here is another example. A man in Utah lives in an old pickup with a camper on top. Car insurance is eating him alive. He simply drives to Foley, Alabama and walks out the door with plates in five minutes! He drives a 1970 Ford. In this case he needs no insurance, title, inspection, or any other paperwork!

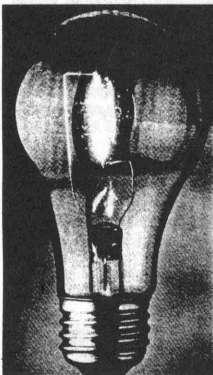
The Nut in the Popcorn

Like Spam Bills or Hate Them? Vote Now

"I think people on the Web want regulations, but not from the US government," said the president of InterGOV Web Site. "Jurisdictionally it doesn't make sense for the US to regulate a global medium." The site offers Internet users worldwide the chance to vote on antispam legislation proposed by Senator Frank Murkowski (R-Alaska) and Representative Chris Smith (R-New Jersey). The bills differ in that Murkowski's would require senders to label junk e-mail as advertisements so that service providers could filter unwanted messages before they're transmitted to end users. Smith's bill would extend a federal prohibition on junk faxes to cover commercial email. The poll opened shortly after Smith's bill was announced earlier this year. Hampton estimated that about 10,000 votes have been registered, and the count is running 8 to 1 against both bills. "Of course, it's unclear whether either politicians will care about the vote," After all these people are not necessarily US citizens." Nonetheless, Hampton said Murkowski has requested the results which the site takes pains to ensure are as accurate as the Web a notoriously suspect polling place allows.

United States District Court Judge Claudia Wilken has rejected another attempt by the Federal Communications Commission to silence Berkeley Micro Radio Broadcaster Stephen Dunifer, founder of Free Radio Berkeley. In a 13 page opinion released on November 12, 1997, Judge Wilken once again rejected the government's motion for an injunction to silence micro radio broadcasts by local radio pioneer Stephen Dunifer.

In 1995, Judge Wilken rejected the government's first motion for a preliminary injunction against Dunifer's broadcasts. At that time the Court found merit in Dunifer's argument that the FCC's ban on low power, affordable FM

broadcasting was a violation of the First Amendment's guarantee of free speech to all in the United States.

In a blatant attempt to avoid facing its First Amendment obligations the FCC then urged Wilken to permanently enjoin Dunifer from Broadcasting and at the same time argued that she could not even consider the issue of whether its rules, which prevent him from getting a license, are unconstitutional. In a Kafkaesque argument, the Commission argued that Wilken had jurisdiction to issue an injunction, but no jurisdiction to hear Dunifer's constitutional arguments. The government claimed that only the higher federal courts could consider the constitutional question.

In her November 12 decision rejecting the Government's position, Judge Wilken pointed to the fact that the FCC had taken exactly the opposite position in the 1994 case of *Dougan vs FCC*. In that case, an Arizona micro radio broadcaster had appealed an FCC fine (for broadcasting without a license) to the 9th Circuit Federal Court of Appeal, and the FCC had argued that the Court of Appeal had no jurisdiction over the case, and that it had to be heard by the District Court. The Court of Appeals agreed with the FCC and sent the case back to the District Court.

Judge Wilken noted that the Arizona broadcaster had raised the same constitutional arguments in the Court of Appeals that Dunifer is raising. The Court ruled that in sending all of the issues in the Arizona case to the District Court, the Appeals Court recognized that the District Court had jurisdiction over all aspects of the case.

In denying the Government's motion for an injunction "without prejudice," Judge Wilken ordered the Government to file a further brief on the question of whether the unconstitutionality of the FCC's ban on micro radio is a valid legal defense to an injunction against broadcasting at low power without a license. Dunifer's attorneys, Louis Hiken and Allen Hopper of San Francisco, will have an opportunity to rebut the government's arguments on this point.

In response to pressure from the commercial broadcaster's lobby, the National Association of Broadcasters (N.A.B.), the FCC has in recent months been stepping up its campaign of harassment against the thousands of micro radio stations now on the air in this country. Hiken commented "The broadcast industry is clearly afraid of these little community stations which are speaking truth to its power. In trying to do the N.A.B.'s bidding, the FCC demonstrates that it is nothing but an enforcement arm of the commercial broadcast industry and the multi-national corporations which own it."

The National Lawyers Guild's Committee on Democratic Communications has represented the Lawyers Guild, San Francisco's Media Alliance, and the Women's International News Gathering Services as a "Friend of the Court" (Amicus) in this case. In its Friend of the Court brief the Lawyers Guild pointed out that FCC regulations make it impossible for all but the very wealthy to even apply for a broadcast license. This, they told the Court, is the equivalent of saying anyone could speak from a soap box in the park, but the box had to be made of gold. Guild attorney Peter Franck commented "In an era when Disney owns ABC, the world's largest defense contractor owns NBC and CNN merges with Time which merges with Warner, and when 'public' broadcasting is told to get its money from corporations, micro radio may be our last best hope for democracy on the air ways." He continued "Judge Wilken's decision is a courageous rejection of the Government's attempt to use a legal Catch-22 to avoid facing the fact that its ban on micro radio flies in the face of the Constitution."

The legal team representing Dunifer and the Amicae are very pleased with Judge Wilken's reasoned and thorough decision denying the FCC's motion to have the case resolved without a trial on the merits. For almost 70 years, the FCC has catered solely to the interests of commercial corporate giants, through their mouthpiece, the National Association of Broadcasters. These are the pirates, who have stolen the airwaves from the American people, and who represent corporate interests valued at more than 60 billion dollars. Only the Pentagon, the Silicon Valley and the transportation industries possess the financial wallop represented by the NAB and its constituents.

Judge Wilken's decision represents a vision of what it would be like for the American people to be given back their own voice. The decision suggests the likely unconstitutionality of the entire regulatory structure underlying the FCC's ban on low power radio. It forewarns of the total failure of that agency to carry out its statutory obligation to regulate the airwaves in the public interest -- that is, in the interest of the American people, rather than the media monopolies that control our airwaves.

The legal team welcomes the opportunity to have a court identify the real pirates of the airwaves -- not the thousands of microradio broadcasters who seek to communicate with the people of their communities, but rather the billionaire commercial interests that control the airwaves as if they own them. Is it General Electric, Westinghouse and the Disney Corporation that have the right to control local community radio, or is that a right that belongs to all of the American people, regardless of economic status?

A RED BOXERS' DREAM

First of all I'd like to thank Radio Shack for carrying the memory dialers we all so love (they stopped shipment on them for a while), and modified parts so the red box conversion was inapplicable. But then, Radio Shack started losing money and quickly reinstated the old memory dialers. As most people know you cannot red box from phones that the mouthpiece is muted, how do you know whether or not your mouthpiece is muted?

Simply blow into the receiver, if you hear an echo in the ear piece you can red box from it. Another nasty trick the telco put on the phones is volume control, you can forget 'bout boxing from those. And of course how can we forget the unboxable COCOT. Seems you'll never be able to box from those, right? Wrong!! We found a hole in the system, and the best thing of all is that you still get to box from bell phones too, without changing the crystal twice. Here's what ya do. Instead of replacing the original with a 6.5000MHz or a 6.5900MHz use either a 6.3000MHz or a 6.37000MHz, and do as you would with a 6.5MHz. it's just that now you can include most COCOTS along with Bell phones. We also found a way around the muted phones too.

First find a Bell phone that you can box from and unscrew the receiver. Now take out the mic (the flat round piece made out of brass), it should fall right into your hands with NO WIRES CONNECTED TO IT. If your having trouble with unscrewing the receiver then try a pair of channel locks (a pair of oversized pliers used for pipes). Now we suggest that when removing the mic you do it at night time. It would look really suspicious if a teen aged kid with a pair of channel locks was trying to vandalize the phone receiver. Once you have the mic you then go to another phone that is muted or if you're walking around and come across a muted phone (note: the mic is only about the size of a silver dollar) unscrew the receiver and replace the mic. Now you will be able to successfully red box from a 'muted' phone (note: this will not work with phones that have volume control).

Now instead of a tone dialer I use what's called a digital voice recorder (or DVR). The Sharper image puts out the Voicelt Digital Recorder with a PC capability. It runs you about #300. It's a little more than the \$50 for a tone dialer but worth it. Some say recordings of quarter tones don't work anymore, but that's where digital comes in. Digital recorders playback same speed accuracy. Regular tape recorders playback slower with battery life, motors and gears. So it's well worth the investment. Don't get me wrong, I always carry my tone dialer (like a reverend carries his Bible). Hopefully this will help out all you hard kore phreakers out there. And keep the telco's on their toes!

FACTUAL INFORMATION ABOUT JURY SERVICE FROM THE FULLY INFORMED JURY ASSOCIATION

TRUE OR FALSE ?

True or False?

When you sit on a jury, you may vote on the verdict according to your own conscience?

"TRUE, you say--and you're right. But then...

[1] Why do most judges tell you that you may consider "only the facts"--that you are not to let your conscience, opinion of the law, or the motives of the defendant affect your decision?

In a trial by jury, the judge's job is to referee the trial and provide neutral legal advice to the jury, beginning with a full and truthful explanation of a juror's rights and responsibilities.

But judges rarely "fully inform" jurors of their rights, especially their power to judge the law itself and to vote on the verdict according to conscience. Instead, they end up assisting the prosecution by dismissing any prospective juror who will admit to knowing about this right--starting with anyone who also admits having qualms with the law.

We can only speculate on why: Distrust of the citizen jury? Disrespect for the idea of government "of, by, and for the people"? Unwillingness to part with power? Ignorance of all the rights and powers that trial jurors necessarily acquire upon assuming the responsibility of judging a case? Actual concern that trial jurors might "misuse" their power if told about it?

[2] How can people get fair trials of the jurors are told they can't use their consciences?

Many people don't get fair trials. Too often, jurors actually end up apologizing to the person they've convicted--or to the community for acquitting when evidence of guilt seems perfectly clear.

Something is definitely wrong when the jurors feel ashamed of their verdict. They should never have to explain "I wanted to use my conscience, but the judge made us take an oath to apply the law as given to us, like it or not."

Too often jurors who try to vote their consciences are talked out of it by other jurors who don't know their rights, or who believe they are required to reach a unanimous verdict because the judge "said so."

If jurors were supposed to judge "only the facts", their job could be done by computer. It is precisely because people have feelings, opinions, wisdom, experience, and conscience that we depend upon jurors, not upon machines, to judge court cases.

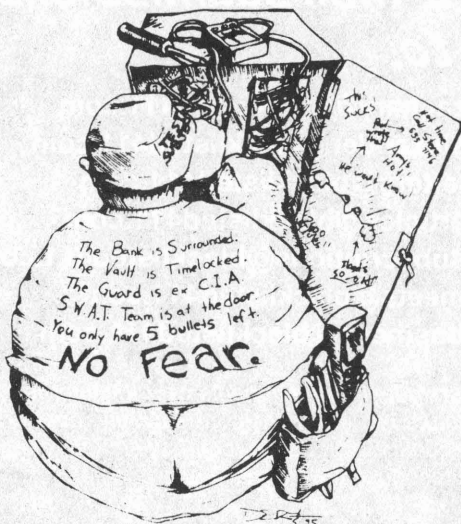
When it's your turn to serve, remember:

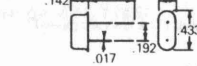

What is the Fully Informed Jury Association--"FIJA"

"FIJA" is a national jury--education organization which both educates juries and promotes laws to require that judges resume telling trial jurors "the who truth" about their rights, or at least to allow lawyers to tell them. FIJA believes "liberty and justice for all" won't return to America until the citizens are again fully informed of their power as jurors, and routinely put it to good use.

Resume? Did judges fully inform jurors in the past?

Yes, it was normal procedure in the early days of our country, and in colonial times. And if the judge didn't tell them, the defense attorney very often would. The nation's Founders understood that trials by juries of ordinary citizens, fully informed of their powers as jurors, would confine the government to its proper role as the servant, not the master, of the people.

John Adams, our second president, had this to say about the juror: "It is not only his right, but his duty...to find the verdict according to his own best understanding, judgment, and conscience, though in direct opposition to the direction of the court."

Our third president, Thomas Jefferson, put it like this: "I consider trial by jury as the only anchor yet imaged by man by which a government can be held to the principles of its constitution."

These sound like voices of hard experience. Were they?

Yes. only four decades earlier, a jury had established freedom of the press in the colonies by finding, John Peter Zenger not guilty of seditious libel. He had been arrested and charged for printing critical-- but true--news stories about the Governor of New York Colony. "Truth is no defense", the court told the jury! But the jury decided to reject bad law, and acquitted.

Why? Because defense attorney Andrew Hamilton informed the jury of its rights; he related the story of William Penn's trial--of the courageous London jury which refused to find him guilty of preaching Quaker religious doctrine(at that time an illegal religion). His jurors stood by their verdict even though held without food, water, or toilet facilities for four days.

The jurors were fined and imprisoned for refusing to convict Will Penn-- until England's highest court acknowledged their right to reject both law and fact, and to find a verdict according to conscience. It was exercise of that right in Penn's trial which eventually led to recognition of free speech, freedom of religion, and of peaceable assembly as individual rights.

American colonial juries regularly thwarted bad law sent over from mother England. Britain then retaliated by restricting both trial by jury and other rights which juries had won or protested. Result? The Declaration of Independence and the American Revolution!

Afterwards, to forever protect all the individual rights they'd fought for from future attacks by government, the Founders of these United States in three places included trial by jury--meaning tough, fully informed juries --in our Constitution and Bill of Rights.

"Bad law"--special-interest legislation which tramples our rights--is no longer sent here from Britain. But our low legislatures keep us well supplied...That is why today, more than ever, we need juries to protect us!

Why haven't I heard about "jury rights" before now?

In the late 1800's, powerful special-interest groups inspired a series of judicial decisions which tried to limit jury rights. While no court has yet dared to deny that juries can "nullify" or "veto" a law, or can bring in a "general verdict", some--hypocritically--have held that jurors need not be told about these rights!

Today, its a rare and courageous attorney who will risk being cited for contempt for telling jurors their powers without first obtaining the judge's approval.

However, jury veto power is still recognized. In 1972 the D.C. Circuit Court of Appeals held that the trial jury has an "...unreviewable and irreversible power...to acquit in disregard of the instruction on the law given by the trial judge. The pages of history shine upon instances of the jury's exercise of its prerogative to disregard instructions of the judge; for example, acquittals under the fugitive slave law." (473 F.2d 1113)

What will happen when proposed FIJA laws are passed?

Three good things:

[1] Unjustly accused persons and their trial jurors, as well as crime victims and their communities, will more often be satisfied that the jury system actually delivers justice.

[2] Legislators will again receive regular feedback from ordinary people, sitting on juries, as well as the usual high pressure from special-interest groups, lobbyists, and other political sources. With better information, they can better represent the people.

[3] When the laws of the land respect the will of the people, as revealed by their jury verdicts, people in turn, will show more respect for the law.

--STARTING TODAY--

***BE AWARE!** Thousands of harmless citizens are in prison today only because their trial juries were not fully informed, and the U.S. now leads the world in percent of population behind bars! More prisons are being built than ever before--for those whose "crime" is to upset the government "master", and not to victims anyone.

***BE ALERT!** Consider every day to be Jury Rights Day. Be wary and/or critical of any proposals to "streamline" the jury system, or to create jurisdictions or regulations which "do not require" trial by jury (two of the means by which your power as a juror is stolen!)

Is this a good law?

If so, is the law being justly applied?

Was the Bill of Rights honored in the arrest?

As a juror, if you answer "no" to any of these questions, your vote should be "not guilty!"

I think my charming, science fiction addicted wife and I will curl up and watch a few good movies, serious classics worthy of the end of an age. Sharing these with you might inspire you to do the same, and certainly you can come up with some great ones, some appropriate films I've missed. In no particular order (yet), my selections are presented for your approval. So, on that note, here goes.

1. METROPOLIS (1984 enhancement of the 1927 film) Fritz Lang's disturbing classic is, I think, ideal as a kickoff for the indoor celebrating of the new millennium. Georgio Morodor's excellent rock and roll soundtrack and very mild, almost sepia colorization make it my choice over the silent original (the update is also silent, but the original has no musical score).
2. BLADE RUNNER (1982) What more needs to be said about this one? Oh, my choice is the original video, not the director's cut. Harrison Ford's background narration is fabulous.
3. MODERN TIMES (1936) Charlie Chaplin's satire on the future, from nearly three-quarters of a century ago, will give great comedic perspective to the last weekend of the age. Chaplin's film on the fears of automation (among other things), and his "Little Tramp" character, were the inspiration of the original IBM personal computer ads, for those of us who can remember back to August of 1981. Now, most PC users do not use IBM on the desktop (or Apple or Radio Shack for that matter, the only players that really mattered in the summer of '81), nor do they remember Chaplin's "tramp" character as an adman, just the tramp.
4. BRAZIL (1986) A lot of people, even many science fiction degenerates, do not like BRAZIL or its British, caustic comedy. I think if George Orwell were to have written a futuristic comedy (no, "1984" does not count), it would look a lot like BRAZIL. Bureaucratic in the extreme, dark, weird, governmentally intrusive, dystopian and funny all at once, BRAZIL will make a lot of 2000-eve parties.
5. ALIEN (1979) The original, minimalist space horror show was still the best of the series for me. So many people have asked me WHY I think so much of the future will look like ALIEN, I have to enumerate: the commercialization of space by non-astronauts/non-engineers, unions and rules for bonuses, strict rules of contact established by a distant, all-owning Corporation ("The Company" as it was so mentioned; in a later film we learn its name is Wayland-Yutani, a very global sounding conglomerate). In my view, H.R. Giger's beast is secondary to the dark view of commercialized, industrialized, unionized space. A fitting view of the near-future, in my humble opinion. Well, if my plans for new clients and much more business don't pan out for 2000---maybe Wayland-Yutani will be hiring.

Just when you thought it was safe to read *Blacklisted!* 411.....

6. 2001 - A SPACE ODYSSEY (1968) Since we don't yet have HAL, a manned moon base, an on-orbit port in Von Braun's classical "double wheel" design, or Jupiter space transport capability, this is in some ways the least prescient of modern science fiction films. Too clean and too utopian for some, it is still a film of beauty, one I see with my children every couple of years. I'll see it then, too.

7. BRAINSTORM (1983) Probably the last view we had of the Osborne 1 "luggable" PC, and certainly our last view of Natalie Wood, this film has yet to catch on, but it struck all the right cords with me. The promise of usable brain downloads is still in the realm of the Sci-Fi Channel (unfortunately), but the Research Triangle, N.C. setting, the very believable, very human scientists and technicians, and the military-industrial-entertainment complex subplot make this a real satisfying movie. I've watched it a number of times, usually late at night when I'm too tired to sleep. It's part of my permanent video library, and it will be ready for the party of 2000.

That's right, there are not 10 movies here because this is not a "Top 10" list. This is MY list, one to be enjoyed (that is, the movies listed thereupon), and one that can be added to by input from friends, business contacts of like mind, and possibly some ideas from you dear BLACKLISTED readers.

That's about it for my stay-at-home celebrating. There will be many more opportunities for me to celebrate by traditional or alternative means AFTER January 1, 2000. Like, getting new clients and having more money to spend. Getting one of those Cray-implosion Pentium-3 laptops that'll be around by then. SSN: MANDATORY OR VOLUNTARY

The Social Security Number (SSN) is a strange beast. Ostensibly intended to help distribute government benefits to American citizens. It therefore seems benign, desirable (of course, cheese also seems "benign, desirable" to mice).

I first became interested in the use of the SSN about 5 years ago after a company placed an erroneous debt on my credit bureau of which I did not owe. Being ignorant as hell at that time I sought the council of an attorney. It was told to me that "we are sorry, but it is not equitable for us to do anything for you!" Well, after being told basically that I would either have to pay this erroneous debt or not pay and it remain on my credit bureau. I decided to fight these pieces of human shit. I discovered through extensive study and cross reference of the United States Code (Federal Statutes), American Jurisprudence "Am Jur" (comprehensive text of American law on both state and federal law). I can say after 5 years of studying this subject that the biggest lie in history is being forced on the American public and we are too stupid (like cattle) not to know it.

The Privacy Act itself contains an uncodified section within it. This is called a statute at large because congress deliberately failed to assign this section of the title with a number making it impossible to find it. It states:

Disclosure of social security number, section 7 of Public Law 93-579 provided that: "(a)(1) It shall be unlawful for any federal, state or local government agency to deny any right, benefit or privilege provided by law because of such individuals refusal to disclose his social security account number. (2) The provisions of paragraph (1) of this subsection shall not apply with respect to-

(b) Any federal, state or local government agency which requests an individual to disclose his social security account number shall inform that individual whether that disclosure is mandatory or voluntary, by what statutory or other authority such number is solicited, and what uses will be made of it."

Now, here is a simple question to ask yourself. If my own government is not entitled to know my SSN except under certain terms and conditions (there are only 4 instances when you must provide to your government, found at title 42 USCS sec. 301 et. seq., 405(c)(2)(i,iii)), what makes you think that you are going to disclose your SSN to video store to rent a movie, to a utility

company for service hookup, to purchase a handgun, to write a check at Wal-mart. The answer to this question is defined in law as compelled. You voluntarily disclosed the information or submitted voluntarily thinking that if you did not disclose the information you would be denied service. When in reality law states you cannot be denied any right, benefit, or privilege provided by law because of your refusal to disclose your SSN. Example, the bank cannot be lending credit unlawfully, the video store cannot be contracting out movie rentals to the public unlawfully.

Case site

"An agency is a relation created by express or [implied contract] or by law, whereby one party delegates the transaction of some lawful business with more or less discretionary power to another." State Ex. Real. Cities Service Gas v. Public Service Commission, 85 SW 2d. 890.

Keeping in mind that it is (presumed) that you knew your rights in not disclosing you SSN to any government agency, corporation, or individual. Any agency, corp., or individual can ask you for your SSN but, it is (presumed) that you knew your rights not to disclose your SSN. Law defines this act as presumption.

Obviously nothing in life is simple. You cannot walk into any institution and demand service and simply state "well, I'm not going to give you my SSN!" You must be able to assert your right, defend it, counter challenge, any objection to the stand on your right. Law is no guarantee of justice either. This is why I have wrote this two detail booklet to help give the average person the tools and the laws to defend themselves. A simple way to help you understand whether or not this uncodified section applies to corporation is for you to go to your local Taco Bell and ask for an employment application. Look at the block where they ask for your SSN. It states "optional."

The benefit to you in not disclosing your SSN is that the institution cannot access your credit file, track you by computer file in the creation of a dossier. Prevent intrusions into your right of privacy. And when any institution will not comply with law the same way you and I must do, I look to the Declaration of Independence for guidance.

"That to secure these rights, governments are instituted among men, deriving their powers from the consent of the governed. That whenever any form of government becomes destructive of these ends, it is the right of the people to alter or abolish it, and to institute new government, laying its foundation on such principles and organizing its powers in such form, as to them shall seems most likely to effect their safety and happiness."

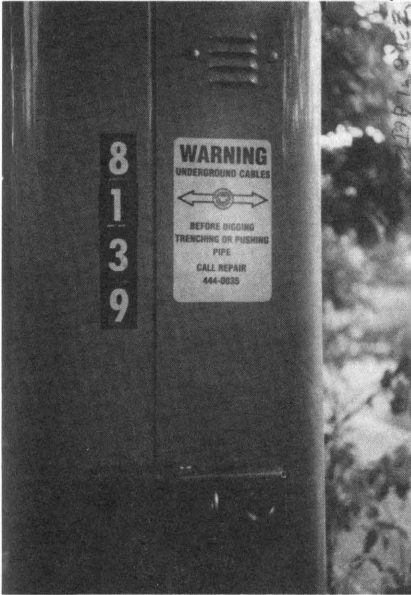

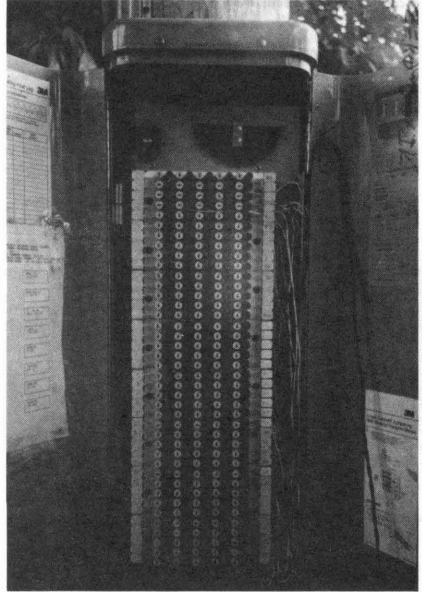
